## **CONDITIONS RELATED TO REGISTRATION**

- Application should be prepared by the supplier on own as per the specimen given in the application. All applications should be submitted under registered post, cover marked "Registration of Supplies/Services – 2025" on the left-hand corner of the envelop.
  - Application form and other details will be also be available in the University website <u>http://www.vau.ac.lk</u> downloaded application forms should accompany with the Deposit slip and Application for Registration should be sent addressed to the **Bursar**, **University of Vavuniya**, **Mannar Road**, **Pambaimadu**, **Vavuniya on/before 30**<sup>th</sup> **November 2024**.
- 2. Separate applications should be submitted along with copies of relevant documents for supply of each category of Goods and Services. (Ex.: If applying for 05 items, 05 perfected applications and 05 relevant documents should be submitted.)
- 3. A registration fee of **Rs.1,000.00 (Nonrefundable Deposit)** should be paid along with each application submitted for registration as suppliers.
- 4. A separate deposit is made for each category. If registration fee is paid by cash Deposited to the Account No 0002364602 in the Bank of Ceylon, Vavuniya by denoting the deported as "2025 RES (Your company name)". Otherwise, application may be obtained upon payment to be Shroff of the University of Vavuniya, Pambaimadu Vavuniya on working days from 9.00a.m to 3.00p.m.
- 5. ICTAD/CIDA registration is essential for contracts (Construction and Rehabilitation of Buildings Item No.64) above Rs.200,000.00 and the copy of the relevant Registration Certificate should be submitted with the application.
